ORDER:-

In the G.O. first read above, orders were issued exempting the physically handicapped persons, whose family income does not exceed Rs.200/-p.m. from the payment of application fees for appearing the examinations conducted by the Tamil Nadu Public Service Commission for recruitment to public services. In the G.O. second read above, the income limit was enhanced from Rs.200/- to Rs.350/- p.m. for the above purpose.

2. In his letter third read above, the Secretary, Tamil Nadu Public Service Commission has stated that the physically handicapped persons have represented to the Commission, explaining their difficulties in getting the Income Certificate for Rs.350/-p.m. as prescribed by the Government for claiming exemption from payment of examination fee and therefore they have requested to remove the income limit of Rs. 350/- p.m. which has no relevance in the present day situation. The Secretary, Tamil Nadu Public Service Commission has therefore recommended to exempt all the physically handicapped candidates from payment of examination fee prescribed for appearing for all the examinations conducted by the Commission for

p.t.o.

Recruitment to various posts, as one of the welfare measures for the upliftment of the physically handicapped persons and for improvement of their social status.

3. The Government after careful examination have decided to accept the recommendation of the Secretary, Tamil Nadu Public Service Commission. Accordingly, they direct that all the physically handicapped persons be exempted from payment of the examination fees for appearing for all the examinations to be conducted by the Tamil Nadu Public Service Commission for recruitment to various posts in the State.
