## **ORDER:-**

The State Commissioner for the Differently Abled has reported that there are 2250 Mentally Retarded Persons in the age group of 0-18 years as per the recent survey conducted by the District Differently Abled Welfare Officer, Cuddalore and that there is a pressing need for establishment of a Special School for the Mentally Retarded Children in Cuddalore District.

- 2. The main objective for the establishment of Special School is to identify infants and young children in the age group of 5-14 years with Mental Retardation and associated Disabilities (Viz) Autism, Cerebral palsy and Multiple Disabilities, and to provide Special Education to them along with support counseling and training to their parents and families to optimize their potential in the development areas of movement, socialization and understanding of such children and make them independent as far as possible in handling their daily routines without assistance from others.
- 3. These children will be given stimulation and Special Education as per their individual needs and a maximum of 50 children will be admitted to the School. The teacher student ratio required will be 1:8 and care givers will be appointed at the rate of 1:15.
- 4. Therefore, the State Commissioner for the Differently Abled has requested orders to establish, a Non Residential Special School for children in the age group of 5-14 years in Kattumannarkoil, Cuddalore District, through a reputed Non Governmental Organization (NGO) and for sanction a sum of Rs.11,40,000/- (Rupees Eleven Lakhs and forty thousand only) per annum as a grant –in aid to the NGO so selected from 2010-2011.
- 5. The Government have examined the proposal of the State Commissioner for the Differently Abled in detail and decided to accept it. Accordingly:-

- i. The State Commissioner for the Differently Abled is permitted to establish, a Special School for the Mentally Retarded Children in the age group of 5-14 years through a reputed Non Governmental Organization (NGO) in Kattumannarkoil, Cuddalore District.
- ii. A sum of Rs.11,40,000/- (Rupees Eleven Lakhs and forty thousand only) is sanctioned as per the annexure to this order as annual grant-in-aid (GIA) to the selected Non-Governmental organization (NGO) to run the Special School at Kattumannarkoil, Cuddalore Distract in special education training and rehabilitation of children with mental retardation in the age group of 5-14 years.
- iii. A Non Governmental Organization (NGO) having experience in the field of teaching and rehabilitation of children with Mentally Retardation will be selected by a Committee headed by the District Collector as Chairperson with District Differently Abled Welfare Officer, Joint Director of Medical Services and one Psychiatrist or clinical psychologist as members of the Committee. Based on the recommendations of the Committee, the State Commissioner for the Differently Abled is permitted to accept and approve the NGO so selected and sanction the funds to the NGO through the District Differently Abled Welfare Officer, Cuddalore.
- iv. The selected NGO is permitted to select the trade of the Pre Vocational Training as per the local needs / requirements as per general guidelines of the Grant in Aid (GIA) scheme of Government of India.
- v. In case of complaints, the State Commissioner for the Differently Abled is permitted to decide on the removal of NGO, based on the recommendation of the District Collector however after providing sufficient opportunity of being heard as per natural justice principles.
- 6. The expenditure shall be debited under the following head of Account:-

"2235-Social Security and Welfare – 02 – Social Welfare – 101 – Welfare of Differently Abled Persons – Schemes in the Eleventh Five Year Plan - II State Plan – MG – Assistance to reputed NGOs. for Special Institution for Mentally Retarded 09 – Grants – in – Aid – 01 – Grants for current expenditure" (D.P.Code.:2235-02-101-MG-0914)

- 7. In the special school for the Mentally Retarded, the Head master, Junior and Senior special teacher and Vocational instructor will be appointed as per the qualification detailed below:
  - i. Junior or Senior Diploma in Mental Retardation awarded by the Directorate of Government Examinations. Government of Tamil Nadu.
  - ii. Post Graduate Diploma in Special Education (MR) offered by Madurai Kamaraj University.
  - iii. B.Ed., in Special Education in Mentally Retardation awarded by BHOJ University.
  - iv. Post Graduate Diploma in Special Education (MR) offered by National Institutes (or) any other qualification approved by RCI.

#### For Vocational Instructor:-

- Diploma in vocational Training and Employment (Mentally Retarded)
